Sub: Pre-examination Training for fresh SAS and Revenue Audit Exam candidates

As per the provisions contained in Para 9.2.8 of C&AG's MSO (Admn.) Vol. I, the officials who intend to appear in SAS Exam, will have to undergo a Pre-examination Training which is required for appearing in the said examination for the first time as a fresh candidate.

2. Further, as per provisions contained 9.3.1.1 of C&AG's MSO (Admn.) Vol. I, read with Circular No. 801-Staff(App.1)/07-2014 dated 17-07-2014 issued from the Headquarters Office, training requirement for RA Exam candidates is under:-

a) For following categories of officials, training requirement is not compulsory in papers RAE-1 and RAE-2:

i) Sr. AOs/AOs who have rendered one year of continuous service in RA Branch as AAO/AO/Sr. AO.

ii) Departmental officials promoted as AAO and have completed one year of continuous service in RA Branch as AAO.

iii) Confirmed DR AAOs who have completed one year of regular service in RA Branch as Regular AAO.

iv) Pre-examination Training in RAE-10 paper is however mandatory for above categories of officials for being eligible for appearing in RA Exam as fresh candidate.

b) All other Sr.AOs/AOs/AAOs will have to undergo Pre-examination Training in all three papers RAE-1, RAE-2 and RAE-10 for being eligible for appearing in RA Exam as fresh candidate.

3. It has been noticed on the recent occasions that attendance in the said Pre-examination SAS/RAE Trainings conducted In-house and /or by the Regional Training Institute, Kolkata was not satisfactory in respect of a number of candidates who remained absent from the training on different grounds. This has been viewed seriously by the competent authority.

4. It has been decided that, henceforth, the candidates who would not undergo the training for full duration may not be allowed to appear in the respective examination except in cases where the competent authority is satisfied that the absence was caused due to reasons beyond the control of the official concerned.

This issues with the approval of Director General Audit, Central, Kolkata.
