#### **TERMS & CONDITIONS:-**

- **1.** Bidders should be Original Manufacturers (OM) or Authorized Dealer/Distributor OEM/any other dealer/proprietorship firm who may fulfil other terms & conditions mentioned below.
- 2. The Bidder should be registered with the Income Tax Department. Supporting documents viz. Copies of VAT Registration, Income tax Registration (PAN) shall be required to be submitted with the bid.
- 3. Tenderer should quote rate for procurement of 100 no. of Bags.
- **4.** Bid price should be **inclusive of all taxes**, **levies**, **delivery charges etc**. No subsequent upward revision in rate(s) shall be accepted by this office. The bid price of each item should commensurate with the prevailing market rate for such items.
- **5.** Each paper of bidding document should be signed and stamped by the bidder or by his authorised signatory. The envelope containing the tenders (quotations) should be sealed and super scribed as "QUOTATIONS FOR SUPPLY OF BAGS".
- **6.** Bidders shall not be permitted to withdraw their offer or modify the terms & conditions after submission of bidding document.
- **7.** L1 bidder must show the sample bag conforming the specification specified in Annexure-II as and when it will be declared by the office.
- **8.** The period of validity of the quoted rate should be for a minimum period of **60 days** from the date of closing of quotation.
- **9.** The competent authority of O/o the Director General of Audit (Central), Kolkata reserve all rights to reject any bids including of those bidders who fail to comply with instruction without assigning any reason whatsoever and does not bind itself to accept the LOWEST or any specific bids.

- (i) Dimension of Bag: 33 cm X 42 cm X 10 cm approx.(Height X Width X Depth) having light in weight.
- (ii) Type: Portfolio bag(iii) Water resistant
- (iv) Material: Nylon dobby/Nylon Oxford.
- (v) Closure: Zip closure
- (vi) Capacity: 15 litres (approx)
- (vii) Compartment: Multiple compartments and pockets including front zippered pocket.
- (viii) Handle/Strap: Two comfortable reinforced handles and a single detachable strap with padded haul loop.
- (ix) Bag may have a no. of pockets/slots to carry the visiting card, Identity card, laptop charger etc. along with 2 pen slots within its compartment.
