#### **TERMS & CONDITIONS:-**

- 1. Bidders should be Original Equipment Manufacturers (OEM) or Authorized Dealer/Distributor OEM/any other dealer/proprietorship firm (who may fulfil other terms & conditions mentioned below.
- 2. The Bidder should be registered with the Income Tax, Service Tax Department. Supporting documents viz. Copies of VAT Registration, Income tax Registration (PAN) and service tax registration shall be required to be submitted with the bid.
- 3. Tenderer should quote rate on **Buy-back offer** for the existing old 03 no.s of High Back Chairs and 17 no.s of Mid Back chairs. Bid price should be **inclusive of all taxes**, **levies**, **delivery charges etc**. No subsequent upward revision in rate(s) shall be accepted by this office. The bid price of each item should commensurate with the prevailing market rate for such items. Bidders are requested to visit the office to see the old chairs which are to be replaced on Buy back.
- **4.** Each paper of bidding document should be signed and stamped by the bidder or by his authorised signatory. The envelope containing the tenders (quotations) should be sealed and super scribed as "QUOTATIONS FOR SUPPLY OF CHAIRS".
- **5.** Bidders shall not be permitted to withdraw their offer or modify the terms & conditions after submission of bidding document.
- **6.** L1 bidder must show the sample chair conforming the specification specified in Annexure-II as and when it will be declared by the office.
- **7.** The period of validity of the quoted rate should be for a minimum period of **60 days** from the date of closing of quotation.
- **8.** The competent authority of O/o the Director General of Audit (Central), Kolkata reserve all rights to reject any bids including of those bidders who fail to comply with instruction without assigning any reason whatsoever and does not bind itself to accept the LOWEST or any specific bids.
- **9. Location of Supply:** All the items will have to be supplied in the premises of the Office of the Director General of Audit (Central),Govt. Of India Press Building, 8, Kiran Shankar Ray Road, Kolkata-700001, as per the terms and conditions given herein.

#### **ANNEXURE-II**

## **TECHNICAL SPECIFICATION:-**

 SEAT/BACK ASSEMBLY: The seat/back being made up of 1.2 cm thick hot pressed plywood, upholstered with fabric and moulded Polyurethane foam together with moulded seat and back covers. The back foam is designed with contoured lumbar support for extra comfort. The size of chairs are given below.

(HIGH BACK) SIZE: 50.0cm.(W) X 72.0 cm (H) (MID BACK) SIZE: 50.0 cm.(W) X 49.0 cm (H) SEAT SIZE: 50.0 cm.(W) X 46.0 cm (D)

- **2. POLYURETHANE FOAM**: The chairs must have Polyurethane foam is moulded with density at least 45+/-2kg/m³ and Hardness of at least 20+/-2 with at least 25% compression.
- **3. SEAT/BACK COVERS**: It must be Injection moulded in back with co-polymer polypropylene and back cover will be vacuum formed from ABS sheets.
- **4. ARMRESTS:** It must be black integral polyurethane skin with a range of 50-70 Shore Hardness. The armrests will be scratch and weather resistant.
- **5. CENTRE PIVOT MECHANISM**: The centre pivot mechanism will be designed with the following features:

360° revolving type 17° maximum tilt on pivot at center Tilt tension adjustment Upright locking

- **6. PNEUMATIC HEIGHT ADJUSTMENT**: The pneumatic height adjustment will have an adjustment stroke of at least 10.0cm.
- **7. TELESCOPIC BELLOW ASSEMBLY**: The bellow will be 3 piece telescopic type and injection moulded with Polypropylene.
- **8. PEDESTAL ASSEMBLY**: The pedestal will be made up of HR steel and fitted with 5 nos. twin wheel castors (castor wheel dia. 5.0cm). The pedestal must be covered with a P.P. moulded cladding for modern and aesthetic looks.
- **9. TWIN WHEEL CASTORS**: The twin wheel castors will be injection moulded with 30% Glass Filled black Nylon.
